



2024 Winner's Choice Car or Cash Raffle Terms & Conditions

The Chandler Education Foundation (CEF) Winner's Choice Raffle grand prize is the winner's choice of either \$27,000 off the MSRP of any Toyota vehicle or a \$20,000 cash prize payable via company check. By purchasing a ticket to the 2024 Winner's Choice Car or Cash Raffle, the purchaser agrees to comply with the following terms:

1. Raffle tickets may be purchased online through the CEF website at www.ChandlerEdFoundation.org. A link is also available at www.CEF-Raffle.com or via the raffle platform directly at <https://go.rallyup.com/cef-raffle-2024>.
2. The purchase price of one raffle ticket is \$20.00. If payment is dishonored by the bank, the raffle ticket will be declared invalid unless full payment is made prior to 9:00 am on March 6th, 2024. Attempts will be made to reach the purchaser as quickly as possible by telephone, mail, or email.
3. The purchaser will automatically receive an email receipt and confirmation of the raffle ticket purchase with the ticket(s) number(s). If a confirmation is not received, the purchase was not received by the CEF office.
4. Online Raffle tickets will be available for sale until 9:00 am on Wednesday, March 6th, 2024.
5. A limited number of paper tickets will also be available at select CUSD sites. All physical tickets sold off-site must be returned to the CEF office by the seller no later than 9:00 am on March 6th, 2024, to be eligible to win the Winner's Choice Car or Cash Raffle. Any raffle ticket stub and money turned in after this time will be returned to the buyer.

6. If at least 1,000 raffle tickets are not sold by March 1st, 2024, CEF may convert the monies collected to a 50/50 raffle with the winning ticket being drawn on March 8th, 2024. Please refer to Rule # 18 regarding Taxes and IRS Rules.
7. Only ONE name should be stated on the raffle ticket. In the event a winning entry has more than one name listed on the ticket, CEF will physically award the prize to the first name listed on the entry. Neither CEF, its Board of Directors, staff, or their legal counsel are responsible for resolving disputes which may arise from any conflict between or amongst joint ticket holders or purchasers.
8. By entering CEF's 2024 Winner's Choice Car or Cash Raffle, participants confirm that they are at least twenty-one (21) years of age or older and have read, understand, and agree to abide by these rules and procedures. Participants must be present in Arizona at the time of ticket purchase as well as the award of the prize and final transaction of the car or cash.
9. The winner will be determined by a random drawing at 12:00 pm on March 8th, 2024. The winner must notify CEF in writing at info@chandleredfoundation.org within ten (10) business days of their prize selection (car or cash). The prize will be provided to the winner within ten (10) business days of receipt of written notification to allow the details of the raffle to be finalized. The drawing will be live streamed, and a recording of the drawing will be available by link through the CEF website (www.ChandlerEdFoundation.org) within 24 hours of the drawing.
10. The winner is required to claim the vehicle or cash within three (3) months of the final draw date (June 8, 2024). Failure to claim the prize within the designated time frame will result in forfeiture by the winner, and CEF will not hold a second raffle to determine a new winner.
11. Names of prize winners will be available to the media and all raffle participants, displayed on the CEF website (www.ChandlerEdFoundation.org) and at the Foundation office located at 1851 E. Queen Creek Road, Gilbert, Arizona 85297, within ten (10) business days of the drawing date.

12. Purchase of a raffle ticket constitutes permission for CEF to use the winner's name, address and/or likeness, in perpetuity, for purposes of advertising the raffle or future raffles without further consent or compensation, unless prohibited by law.
13. The "Early Bird" Drawing: All online tickets purchased prior to 9:00 am on February 5, 2024, will be entered into the Early Bird drawing held on February 8, 2024. Paper tickets must be received at the CEF office by 9:00 am on February 5, 2024 to be included in the Early Bird drawing. Early Bird prize winners remain eligible for the final Grand Prize drawing. Early Bird prizes will be listed on the raffle platform page. Winners of Early Bird prizes bear the responsibility of claiming their prize in person at the CEF office located at 1851 E. Queen Creek Road, Gilbert, AZ 85297 no later than March 5, 2024. Receipt of Early Bird prizes is the responsibility of the winner(s), not CEF. CEF cannot mail Early Bird prizes to winners.
14. CEF Board members and CEF office personnel are ineligible to purchase a raffle ticket.
15. Based on CEF's relationship as the Chandler Unified School District's non-profit supporter, and for the purpose of all raffles associated with CEF, a bona fide member of the organization includes the following stakeholders of the Chandler Unified School District: District Administration and Staff, District Supported Boosters, PTA's, PTO's and Boosters, and District Sponsored Clubs and Organizations. CEF's bona fide members representing these Chandler Unified School District groups may participate in the raffle as long as they receive no direct or indirect pecuniary benefit other than being able to participate in the raffle on a basis equal to all other participants.
16. If the winner of the Winner's Choice Car or Cash Raffle chooses the car, the purchase of the Toyota vehicle will be through Big Two Toyota, 1250 S. Gilbert Road, Chandler, 85286. If the winner opts for a vehicle with an MSRP less than \$27,000, no cash refund will be offered by CEF.
17. WAIVER / LIMITATIONS OF LIABILITY: Raffle ticket purchasers, by participating (and winners, by accepting a prize) release the Chandler Education Foundation and Chandler Education Foundation Board of Directors, Chandler Unified School District and their respective parent companies, affiliates, partners, subsidiaries, agents, representatives, sponsors, service agencies and independent contractors, and each of their respective directors, officers, partners, employees and agents, including

advertising and promotion agencies, from any and all liability with respect to participation in the promotion, possession, use and distribution of the prizes awarded, as well as to the necessity to change the date, time or venue of the grand prize drawing due to extenuating circumstances.

TAXES AND IRS RULES: All winners shall be responsible for any and all federal, state, and local income or excise taxes, fees, assessments, and like charges associated with the prizes, including but not limited to title, registration, and transportation fees before taking possession of the prize.

Prizes valued at \$600.00 or greater will not be distributed until CEF has received from the winner a complete and executed IRS Form 5754 and any other documentation as may be required by CEF. At the time of this printing, federal law requires that the corresponding federal income tax withholding for prizes valued at \$5,000.00 or greater must be collected from the winner upon prize distribution. Thus, prizes valued at \$5,000.00 or greater will be distributed only after the amount equal to 24% of the value of the car or cash or appropriate amount as mandated by the IRS has been collected. Federal and state tax withholding laws are subject to change without notice. The withholding laws in effect at the time prizes are distributed will be followed.

20. For this raffle it is understood and agreed that Arizona laws apply.
