By purchasing a ticket to the 2019 Winner's Choice Car or Cash Raffle you agree to comply with the following terms listed below:

- 1. The vehicle used for display and marketing purposes will be a 2019 Toyota vehicle. The vehicle selected by the winner may not be the same vehicle shown in person, in marketing materials or on the website.
- 2. The purchase of a raffle ticket is \$20.00. If an entrant pays by check, the person issuing the ticket will write the ticket number/numbers on that check. If an entrant would like to pay by credit card at a school function or other location, a credit card slip will be manually filled out with the credit card number, purchaser's name, address, email address and telephone number along with the raffle ticket number(s). Alternatively, the purchaser may purchase a ticket online at the website listed below. Additionally, he or she may contact the Foundation office at (480) 224-3030 to purchase raffle tickets. If a check or credit card is dishonored by the bank, the raffle ticket will be declared invalid unless full payment is made prior to the drawing. Any dishonored check or credit card will be considered an invalid entry and the entrant will be notified by telephone or mail.
- 3. Raffle tickets may be purchased via the internet through the Chandler Education Foundation (CEF) website at www.CEF-
 Raffle.com
 The purchaser will automatically receive a confirmation of the raffle ticket purchase.
 If a confirmation is not received, the purchase was not received by the CEF office.
 Upon receipt of the raffle ticket purchase, a CEF staff member will fill out the purchaser's name, address and phone number on the raffle ticket stub. The stub will be placed in the bin with all other "sold" raffle tickets and the remainder of the ticket will be sent to the ticket purchaser.
- 4. Completed raffle tickets are delivered to and must be in the possession of a Chandler Education Foundation representative prior to the drawing on January 27, 2019, to be eligible for the Chandler Education Foundation Winner's Choice Car or Cash Raffle.
- 5. Purchasers of raffle tickets must be 21 years of age or older.
- 6. Chandler Education Foundation Board members and CEF office personnel are ineligible to purchase a raffle ticket.

- 8. Name of the winner will be available to the media and all raffle participants, displayed on the CEF website (www.ChandlerEdFoundation.org) and at the Foundation office located at 1851 E. Queen Creek Road, Gilbert, Arizona 85297. Purchase of a raffle ticket constitutes permission for CEF to use the winner's name, address and/or likeness, in perpetuity, for purposes of advertising the raffle or future raffles without further consent or compensation, unless prohibited by law.

Raffle tickets will be available for sale to those who attend the CEF drawing event until the final call for ticket sales is announced at the event at which time raffle ticket sales will end to everyone. Any raffle ticket stubs and money turned in after the closure of the raffle will be returned to the buyer.
- 10. Winner will be determined by a random drawing on January 27th, 2019 at the CEF Drawing event (drawing location to be determined). The public is invited to attend the drawing. The winner must allow at least three business days after the drawing for the prize to be released to allow the details of the raffle to be finalized.
- 11. Winner will assume responsibility for all federal, state and local taxes, title, registration, and transportation fees before taking possession of the vehicle. - 13. Only **ONE** name should be stated on the raffle ticket. In the event a winning entry has more than one name listed on the ticket, CEF will physically award the prize to the first name listed on the entry. For tax purposes, the prize can be split among all prize winners. Neither CEF, its Board of Directors, staff or their legal counsel are responsible for resolving disputes which may arise from any conflict between or amongst joint ticket holders or purchasers. The Social Security number of the winner must be provided.

22. Internet Sales

By entering CEF's 2019 Winner's Choice Car or Cash Raffle, participants confirm that they are at least twenty-one (21) years of age, are present in Arizona at the time of ticket purchase as well as the award of the prize and final transaction of the car or cash, and have read, understand, and agree to abide by these rules and procedures.

23. Taxes and IRS Rules

All winners shall be responsible for any and all federal, state and local income or excise taxes, fees, assessments and like charges associated with the prizes. The winner shall be responsible for any and all state or local license, title and registration fees associated with the vehicle. Raffle winnings are taxable income and must be reported as such on income tax returns. Prizes valued at \$600.00 or greater will not be distributed until CEF has received from the winner a complete and executed IRS Form 5754 and any other documentation as may be required by the Foundation. At the time of this printing, federal law requires that the corresponding federal income tax withholding for prizes valued at \$5,000.00 or greater must be collected from the winner upon prize distribution. Thus, prizes valued at \$5,000.00 or greater will be distributed only after the amount equal to 33% of the value of the car or cash or appropriate amount as mandated by the I.R.S has been collected. Federal and state tax withholding laws are subject to change without notice. The withholding laws in effect at the time prizes are distributed will be followed.
